Medical Assistant classes provide instruction to prepare students to be multi-skilled healthcare professionals specifically trained to perform in ambulatory settings, such as physician offices, clinics, and group practices, and perform administrative and basic clinical procedures. The Medical Assistant Program (MDCA) offers a Level 1 Certificate (C1) as well as an Associate of Applied Science (AAS) Degree (D).

Certification and Licensure Information

The Medical Assistant program requires that the student take the American Medical Certification Association (AMCA) exam in order to achieve the Medical Assistant Certification (MAC) at the end of the fourth semester (AAS only).

Exams are administered on campus as Laredo College is designated as a testing site for AMCA. Testing is held at the Lerma Pena Building in Room 227. Exams are proctored by the testing center personnel. According to the United States Bureau of Labor Statistics, employment of medical assistants is projected to grow 23 percent from 2018 to 2028. The growth of the aging baby-boom population will continue to increase demand for preventive medical services, which are often provided by physicians. As a result, physicians will hire more assistants to perform routine administrative and clinical duties, allowing the physicians to see more patients.

Medical assistants typically do the following:

- Record patient history and personal information
- Measure vital signs, such as blood pressure
- Help physicians with patient examinations
- Schedule patient appointments
- Enter patient information into medical records
