#### CALL TO ORDER

Closed session meeting with Laredo Community College District Attorney to discuss mediation of EEOC Charge No. 451-2016-00676 and litigation matter styled Cause No. 2015CVZ001646D1; Cynthia Aradillas vs. Laredo Community College; in the District Court, 49th Judicial District, Webb County, Texas pursuant to Texas Government Code Sections 551.071 and 551.074. - Dr. Juan L. Maldonado

At 6:15 p.m., Judge Martinez asked for a motion so the Board could go into executive session. Board Member, Ms. Jackie Leven-Ramos, so moved. The motion was seconded by Board Member, Rene De La Viña. The motion carried.

Ms. Jackie Leven-Ramos, Board Member, made the following motion, "I'd like to make a motion an affirmative vote that the Board approve the payment of \$80,295 in exchange for a resignation and a dismissal of all claims, EEOC charges, subject lawsuit, and a full release." The motion was seconded by Mr. De La Viña. A vote was taken. The motion did not pass (only four votes in favor). Dr. Martinez stated, "I would like to make a new motion for the sum of \$35,000, to be paid to Dr. Aradillas with the agreement of all claims, EEOC claims also be dropped as before with continued employment with Laredo Community College." Ms. Vela seconded the motion. A vote was taken. The motion did not pass (only four votes in favor). Judge Martinez mentioned there is a possibility of this going to litigation.
