The 2nd Public Hearing on Proposed 2019 Property Tax Rate of the Laredo College Board of Trustees convened on Thursday, August 22, 2019, beginning at 6:19 p.m. in the Samuel A. Meyer Board Room located at the Elpha Lee West Building Room 105 at the Fort McIntosh Campus.

CALL TO ORDER

Judge Martinez called the meeting to order and acknowledged the presence of Ms. Rosie Cuellar, Webb County Tax Assessor Collector. Dr. Carranza called the roll. A quorum of the members was present.

2ND PUBLIC HEARING ON PROPOSED 2019 PROPERTY TAX RATE – *MR. CESAR E. VELA, JR.*

Judge Martinez indicated the Board is now convening the 2nd Public Hearing on the proposed 2019 Laredo College Property Tax. He presided as Chair of the Hearing and provided the following information:

- The Laredo College 2019 effective property tax rate for maintenance and operations and debt service combined is \$0.317272 per \$100 valuation. The 2019 property tax rollback rate for maintenance and operations and debt service combined is \$0.340769 per \$100 valuation.
- The Laredo College proposed 2019 property tax rate for maintenance and operations would be \$0.255067 per \$100 valuation. The proposed 2019 property tax rate for debt service would be \$0.073576 per \$100 valuation. The combined proposed 2019 property tax rate for maintenance and operations and debt service would be \$0.328643 per \$100 valuation. This combined property tax rate is less than the rollback tax rate but more than the effective tax rate.
- The second public hearing allows the proponents and opponents of the tax rate to present their views to the Board of Trustees.
- Each proponent and opponent may express his or her views regarding the 2019 proposed tax rate. Each proponent and opponent has up to three minutes to speak.

There being no comments or testimony, Judge Martinez announced the Laredo College Board of Trustees will vote on the proposed 2019 property tax rate at its regular meeting to be held on August 29, 2019 at 6:00 p.m. at the Laredo College Fort McIntosh Campus in the Elpha Lee West Building, Room 105.
