CALL TO ORDER

The construction of the new law enforcement training center will occur on the condition that the Laredo College and the US Department of Homeland Security enter into a binding long term memorandum of understanding with a term of up to 10 years". Discussion followed. Ms. Leven-Ramos called for the vote. Ms. Leven-Ramos seconded the motion; motion carried. Ms. Mares, Ms. Zepeda, and Ms. Vela voted against.

Dr. Carranza moved to approve the inclusion of the remaining projects to the Facilities Master Plan Phase 3. Ms. Leven-Ramos seconded the motion; motion carried unanimously.
