CALL TO ORDER

Ms. Zepeda called the meeting to order. Ms. Leven-Ramos called the roll. Ms. Zepeda announced that a quorum of the members was present, that this meeting was duly called, and that notice of this meeting was posted in accordance with the Texas Open Meetings Act.

## DISCUSSION AND POSSIBLE ACTION

APPROVE THE
CERTIFICATION OF EXCESS
COLLECTIONS FOR DEBT
SERVICE – MS. PATRICIA
BARRERA, DESIGNATED

Ms. Patricia Barrera, Webb County Tax Assessor Collector/Designated Officer, read the certification of excess collections and anticipated collection rate.

I, Patricia A. Barrera, Webb County Tax Assessor Collector, as Tax Collector for the Laredo College, Hereby certify that the excess collections for Debt Service (Interest and Sinking Fund) for the taxable year 2020 is \$868,738.00 as of July 29, 2021 and said amount is true and correct. I further certify that the Anticipated Collection Rate for taxable year 2021 is 104%.

This certification is submitted to Laredo College by the duly designated officer who prepared the 2021 Tax Rate Calculation Worksheet.

Patricia A. Barrera, RTA, Webb County Tax Assessor Collector

Ms. Barrera read the certification of the unencumbered fund amount.

Chief Financial Officer, Budget Officer Or Auditor: Cesar Vela, Vice President of Finance Hereby certifies that the unencumbered fund amount used to reduce debt is \$5,744,805.60 as of July 29, 2021, and that said amount is true and correct.

This certification is submitted to Patricia A. Barrera, RTA, Webb County Tax Assessor Collector who is Laredo College's Designated Officer to prepare the 2021 Tax Rate Calculation Worksheet.

Ms. Leven-Ramos moved to approve the certification of excess collections for debt service. Mr. Rangel seconded the motion; motion carried.

TAKE ACTION ON THE TAX RATE FOR TAX YEAR 2021; TAKE RECORD VOTE AND SCHEDULE PUBLIC HEARING OR MEETING (AS REQUIRED) – MR. CESAR VELA Mr. Cesar Vela, Vice President for Finance, presented the proposed tax rate for 2021 is \$.319441; the current 2020 tax rate is \$.325509. The tax rate is decreasing but valuations are increasing which requires a public hearing. Mr. Rangel so moved to approve. Judge Martinez seconded the motion. Ms. Maria Elena Morales, Chief Deputy for Webb County Tax Assessor Collector, noted that a public hearing needs to be scheduled to vote on the rate. Mr. Vela informed the Board that the public hearing will be scheduled on August 26, 2021 prior to the regular Board meeting. Mr. Rangel amended his motion to include a public hearing for August 26, 2021. Judge Martinez seconded the motion. Discussion took place. Mr. Rangel called for the question; motion carried.

RECOGNITION OF WEBB COUNTY TAX ASSESSOR COLLECTOR – JUDGE MERCURIO MARTINEZ, JR.

Judge Martinez, Ms. Mares, Ms. Vela, and Ms. Zepeda on behalf of the Board complimented Ms. Barrera on her work at the Tax Assessor Collector office.

Mr. Delgado moved to bring up Items 4.F. - Select Financial Advisory Services Provider and Delegate to College President the Authority to Negotiate a Contract and Fees and 4.G. - Select Financial Audit Services Provider and Delegate to College President the Authority to Negotiate a Contract and Fees. Ms. Leven-Ramos seconded the motion; motion carried.

Mr. Vela reported that the Ad Hoc Committee met at 12:00 noon today to evaluate, score, and rank the financial advisory services provider. The scores were:

SELECT FINANCIAL AUDIT SERVICES PROVIDER AND DELEGATE TO COLLEGE PRESIDENT THE AUTHORITY TO NEGOTIATE Mr. Vela reported that the Ad Hoc Committee met at 12:00 noon today to evaluate, score, and rank the financial audit services provider. The scores were:

Mr. Delgado moved to approve the results of the committee to select Garza/Gonzalez & Associates and delegate to the college president to negotiate a contract and fees. Ms. Vela seconded the motion; motion passed.
