CALL TO ORDER	Ms. Zepeda called the meeting to order. Ms. Leven-Ramos called the roll. Ms. Zepeda announced that a quorum of the members was present, that this meeting was duly called, and that notice of this meeting was posted in accordance with the Texas Open Meetings Act.

DISCUSSION AND POSSIBLE ACTION ANNEXATION OF NEW PROPERTY WHICH HAS BEEN ANNEXED BY THE CITY OF LAREDO – MR. CESAR VELA	Mr. Cesar Vela, Vice President of Finance and Administration, asked the Board to approve the annexations of new property. Mr. Vela read the resolution for approval. RESOLUTION ANNEXING NEW PROPERTY HERTOFORE ANNEXED BY THE CITY OF LAREDO INTO THE BOUNDARIES OF THE LAREDO COLLEGE DISTRICT WHEREAS, pursuant to H. B. 1182 passed by the 67th Legislature an election was called and had on April 2, 1983, for the purpose of annexing that portion of the City	
	of Laredo not within the boundaries of the l	

of Laredo not within the boundaries of the Laredo Municipal Junior College District, at which election, a majority of the voters residing within the District as changed by the proposed election, voted in favor of such annexation and such new property were thereby annexed; and,

WHEREAS, subsequent to said election, the name of the Laredo Municipal Junior College was changed to the Laredo College District; and,

WHEREAS, on or about January 17, 2023 the City of Laredo annexed new property, described by metes and bounds in six (6) attached ordinances and being generally described as follows, to wit:

TRACT 1 - ALCE TRACT

Being a 8.69 acre tract of land out of a 15.00 Acre tract of land out of a tract of land conveyed by deed to Polaris Office Suites, Inc., recorded in Volume 5199, Pages 55, Official Public Records, Webb County, Texas situated in Porcion 10, Tomas Sanchez,

Abstract 280, Webb County, Texas, and being more particularly described by the attached metes and bounds.

TRACT 2 – TERRAVAL TRACT

A tract of land containing 3.05 acres, more or less, partitioned out of Lot 1 Block 1, Martinez Plat (5.10 acres), Recorded in Volume 36, Page 8, Webb County Map Records, being more particularly described by the attached metes and bounds.

TRACT 3 – EMERALD RIVERVIEW TRACT

Being a tract of land found to contain 305.40 acres, more or less, situated in Porcion 15, Abstract 53, Jose Prudencio Garcia, Original Grantee and Porcion 16, Abstract 46, Dolores Garcia, Original Grantee within the Webb County, Texas, out and part of the Emerald Riverview Development, LTD. Tract, recorded in Volume 2557, Pages 823-838, of the Deed Records of Webb, County, Texas; this tract being more particularly described by the attached metes and bounds.

TRACT 5 – LOS MILAGROS RANCH II TRACT

Being of tract of land containing 1.96 acres, more or less, being out of a tract land conveyed by deed to Los Milagros Ranch II, LTD., recorded in Volume 1363, Page 417, Official Public Records, Webb County, Texas, situated in Porcion 4, City of Laredo, Abstract 234, Webb County, Texas, said 1.96 acre tract being more particularly described by the attached metes and bounds.

TRACT 6 – 5M WATR INDUSTRIAL TRACT

Being a tract of land containing 388.97 acres, more or less, out of a 348.97 acre tract conveyed to WATR Industrial Properties, Ltd., situated in A-530, Webb Co. school land, original grantee, A-231, City of Laredo, original grantee, A-232, City of Laredo, original grantee and A-233 City of Laredo, original grantee, as recorded in volume 4972, Page 81, Webb County Official Public Records, also being out of also 40.00 acre tract conveyed to 5M Industrial Investments, Ltd., situated in A-232, City of Laredo, original grantee, as recorded in volume 5601, page 334, Webb County Official Public Records and being more particularly described by the attached metes and bounds.

TRACT 7 – SALDANA TRACT

Being all of that certain Lot 23, Block 3, Pinto Valle Industrial Park, Phase I, recorded in Volume 10, Page 19, Plat Records, Webb County, Texas, and being more particularly described by the attached metes and bounds.

WHEREAS, it is found to be in the best interest of the Laredo College District and its residents to extend and annex for college purposes all those new properties within the city limits of the City of Laredo not now within the boundaries of the Laredo College District, as is provided by TEX EDUC. CODE § 130.066.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that those areas annexed by the City of Laredo, set forth and described by metes and bounds in the six (6) attached ordinances, be incorporated and annexed to the boundaries of the Laredo College District for college purposes.

PASSED at Laredo, Texas on this 2nd day of March 2023.

Mr. Rangel moved to approve the resolution. Mr. Delgado and Ms. Leven-Ramos seconded the motion. Mr. Meurer noted that Tract 6 has acres that may be transposed. Mr. Martinez amended the motion to include the correct acreage. Mr. Rangel seconded the motion; motion carried. Mr. Meurer indicated that the main motion needs to be voted on. Motion carried on the main motion.

Mr. Vela asked the Board to approve the purchase of nursing equipment from Laerdal Medical Corporation in the amount of \$292,739.49.
Funding will come from the Governor's Education Emergency Relief (GEER II) Grant through the Texas Higher Education Coordinating Board. Ms. Leven-Ramos moved to approve the purchase. Mr. Delgado seconded the motion; motion carried. Mr. Rangel was not present for the vote.
