WHEREAS, pursuant to Section 6.03 of the Property Tax Code, the Laredo College has received notice on September 19, 2024 from the Chief Appraiser of the Webb County Appraisal District of the 519 number of votes to which Laredo College is entitled to; and

WHEREAS, pursuant to Section 6.03, of the Property Tax Code, each taxing unit entitled to vote on the election may nominate by resolution one candidate for each position to be filled on the Board of Directors; and

WHEREAS, Section 6.03, of the Property Tax Code, provides that the presiding officer of the governing body, shall submit by resolution names of the Laredo College's nominees to the Chief Appraiser of the Webb County Appraisal District before October 15, 2024; and

WHEREAS, the foregoing is a necessary prelude for the preparation of the ballot by the Chief Appraiser of the Webb County Appraisal District, which ballot will be submitted to each of the taxing units prior to October 30, 2024, for further action by the Laredo College; and

WHEREAS, the Laredo College is entitled to cast 519 votes in total for one or more of the nominated candidates.
