The following conditions will apply:

- Students that have been on Scholastic Withdrawal (suspension) 2 or more times are ineligible to enroll. Students may enroll during **Summer 2012**.
- **Student must enroll in the Student Success course (STSC 0101) and complete it successfully, unless student had previously passed the course.**
- **If the student fails to enroll or withdraw from the STSC 0101, student will be dropped from all other courses.**
- Students with grades of "I" (Incomplete) may not petition until the course is completed and a grade is issued.
- Students will not be allowed to enroll as a full-time student; limited to part-time enrollment only. Student may enroll for a maximum of **7 hours only**.
- Students will enroll only for the courses recommended by the Scholastic Withdrawal Committee.
- Students will not be allowed to enroll in Distance Learning classes (on-line courses).
- Students will be required to register in developmental coursework if TSI requirements have not been met.
- Students may be asked to repeat courses with previous grades of "D" or "F."
- Students that are transferring to LCC from another institution must attach a copy of the latest transcript from that other institution (TSI status must be provided).
- Student will be required to meet with a Counselor or Advisor. Student will be required to **meet twice a month**.
- Student will be required to go to Learning Center for tutoring for the subjects they are enrolled.
- Students must file this petition as soon as possible and no later than **January 10, 2012**. **Petitions will not be accepted after this date.**
- **Registration is not complete until you have registered in the Enrollment & Registration Services Center at Ft. McIntosh, Memorial Hall Rm 125 or South Campus, Billy Hall, Bldg. Rm 215.**

*I understand the above stated conditions and I am requesting that the Scholastic Withdrawal Committee review my **one page** petition for permission to enroll. On the attached sheets, I am making a written request for special consideration. I further understand that my failure to fulfill the agreement may lead to my being dropped from classes with a forfeiture of all tuition and fees and may prevent me from future enrollments at Laredo Community College for a time specified by the Scholastic Withdrawal Committee.*
