## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.267675 per \$100 valuation has been proposed by the governing body of LAREDO COLLEGE.

PROPOSED TAX RATE \$0.267675 per \$100 NO-NEW-REVENUE TAX RATE \$0.253446 per \$100 VOTER-APPROVAL TAX RATE \$0.282910 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for LAREDO COLLEGE from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that LAREDO COLLEGE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that LAREDO COLLEGE is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 17, 2023 AT 06:00 PM AT SAMUEL A. MEYER BOARD ROOM, AT THE ELPHA LEE WEST BLDG.,ROOM 105,AT LAREDO COLLEGE FORT McINTOSH CAMPUS,WEST END WASHINGTON ST. LAREDO, TEXAS 78040.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, LAREDO COLLEGE is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the LAREDO COLLEGE BOARD OF TRUSTEES of LAREDO COLLEGE at their offices or by attending the public hearing mentioned above.
