

WAIVER, RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT

LCC INTRAMURAL SPORTS PROGRAM

PLEASE READ THIS DOCUMENT CAREFULLY AND COMPLETELY BEFORE SIGNING. ITS EFFECT IS TO RELEASE LAREDO COMMUNITY COLLEGE, ITS GOVERNING BOARD, EMPLOYEES, REPRESENTATIVES AND OTHERS IDENTIFIED BELOW (COLLECTIVELY "LCC") FROM ANY LIABILITY RESULTING FROM YOUR PARTICIPATION IN INTRAMURAL SPORTS, TO WAIVE ALL CLAIMS FOR DAMAGES OR LOSSES AGAINST LCC WHICH MAY ARISE FROM SUCH ACTIVITIES, AND TO INDEMNIFY AND HOLD HARMLESS LCC.

In consideration of my participation and/or involvement in LCC intramural sports, events and activities (Intramural sports), I, _____, the undersigned, acknowledge, agree to and understand, on behalf of myself, my heirs and assigns as follows:

1. Readiness to compete: Voluntary and of my own free will, I elect to participate in LCC intramural sports. I will only participate in those LCC Intramurals sports for which I believe I am physically and psychologically prepared to participate and/or compete in.
2. Risks associated with participation: I appreciate and acknowledge that participating in LCC Intramural sports involves certain risks (some of which I may not fully appreciate), and I am fully aware that injuries, including sprains, concussions, broken bones, paralysis, death, property damage or other harm could occur to me or others in connection with participation in Intramural sports.
3. Medical consent: I consent to medical treatment, at my own expense, for emergencies that occur during or related to my participation in Intramural sports where I am unable to consent to such treatment. I authorize any official of the Intramural sports activity or a representative of LCC to have me transported to medical facilities at my own expense, if necessary, in the event I sustain an injury.

In consideration of being allowed to participate in any way in LCC Intramural sports, I, the undersigned acknowledge, covenant, appreciate, and further agree that:

4. WAIVER AND RELEASE: I WAIVE ANY AND ALL CLAIMS THAT I, MY ESTATE, HEIRS, EXECUTORS OR ASSIGNS MAY HAVE NOW OR IN THE FUTURE AGAINST LCC, ITS TRUSTEES, OFFICERS, SUCCESSORS, AGENTS, ASSIGNS, SERVANTS, EMPLOYEES, COACHES, REFEREES, VOLUNTEERS, AND OTHER RELATED PERSONS (COLLECTIVELY "RELEASED PARTIES") ARISING FROM OR RELATED IN ANY WAY TO MY PARTICIPATION IN INTRAMURAL SPORTS. I RELEASE THE RELEASED PARTIES FROM LIABILITY AND RESPONSIBILITY FOR ANY CLAIMS OR CAUSES OR ACTION THAT I, MY ESTATE, HEIRS, EXECUTORS OR ASSIGNS MAY HAVE FOR PERSONAL

5. INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH OR OTHER DAMAGES ARISING FROM MY PARTICIPATION IN LCC INTRAMURAL SPORTS.
6. HOLD HARMLESS: I AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES HARMLESS FROM ALL LOSSES, LIABILITIES, DAMAGES, COSTS OR EXPENSES (INCLUDING BUT NOT LIMITED TO REASONABLE ATTORNEY'S FEES AND OTHER LITIGATION COSTS AND EXPENSES) INCURRED BY ANY OF THE RELEASED PARTIES AS A RESULT OF ANY CLAIMS OR SUITS THAT I OR ANYONE CLAIMING BY, THROUGH OR UNDER ME MAY BRING AGAINST ANY OF THE RELEASED PARTIES TO RECOVER ANY LOSSES, LIABILITIES, COSTS, DAMAGES OR EXPENSES WHICH ARISE DURING OR RESULT FROM MY PARTICIPATION IN LCC INTRAMURAL SPORTS.

I HAVE READ THIS WAIVER, RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT AND FULLY UNDERSTAND ITS TERMS, AND I EXECUTE IT VOLUNTARILY.
