## **1. Student Consumer Disclosure**

The Higher Education Act (HEA) of 1965, as amended by the Higher Education Opportunity Act (HEOA) of 2008, requires institutions to notify students annually of their right to receive various consumer information items. ## **2. Privacy of Student Records**

The Family Educational Rights and Privacy Act (FERPA) is a federal law that protects the privacy of student education records and establishes the right of students to inspect and review their educational records and to provide guidelines. The law applies to all schools that receive funds under the applicable program of the U.S. Department of Education.

## 8. Pregnancy and Parenting Students

Laredo College is committed to creating and maintaining a community where all individuals enjoy freedom from discrimination, including discrimination on the basis of sex, as mandated by Title IX of the Education Amendments of 1972 (Title IX). Sex discrimination, which can include discrimination based on pregnancy, marital status, or parental status, is prohibited and illegal in admissions, educational programs and activities. Laredo College hereby establishes a policy and associated procedures for ensuring the protection and equal treatment of pregnant individuals, persons with pregnancy related conditions, and new parents.

As with disability accommodations, information about pregnant students' requests for accommodations will be shared with faculty and staff only to the extent necessary to provide the reasonable accommodation. Faculty and staff will regard all information associated with such requests as private and will not disclose this information unless necessary. Administrative responsibility for these

accommodations lies with the Title IX Coordinator, who will maintain all appropriate documentation related to accommodations.

## 9. Reporting Risk, Fraud, Waste, and Abuse

Laredo College is an organization with strong values of responsibility and integrity. ## 10. Voter Registration

## 11. Information for Crime Victims about Disciplinary Hearings

A student who has been a victim of a crime of violence is entitled to certain rights. Among these are the right to receive notice of administrative hearing outcomes, upon written request. To learn more about

## **12. Notification of Penalty under Texas Law for Making False Alarm or False Report of Emergency**

Texas Education Code 51.219 requires colleges to advise all incoming students that Texas Penal Code 42.06(b) provides that making a false alarm or report of an emergency involving a public institution of higher education is a state jail felony. A state jail felony is punishable by a fine of up to \$10,000 and a jail term from 180 days to two years.

## **13. Academic Responsibilities & Communication**

Students are expected to familiarize themselves thoroughly with the regulation of the college, to accept responsibilities for course requirements for their degrees, and to make inquiries in case of doubt. It shall not be the **Laredo College** responsibility should complications arise because of failure to follow regulations and requirements. Regulations will not be waived nor exceptions to requirements made on a plea of ignorance. Students, therefore, should become familiar with all the information related to their program of study contained in the online [College Catalog](#).

## **14. Grade Appeal Process**

### **GRADE APPEAL**

#### **TIME LIMIT FOR APPEALING A GRADE:**

A student who wishes to question a grade received for a class should first discuss the situation with the instructor of record who issued the grade. If the issue is not resolved, the student should contact the appropriate Department Chairperson to review the concern. If the student is not satisfied with the Department Chairperson's decision, the student may contact the appropriate Dean of Instruction for assistance. If necessary, the student may request a review by the Provost/Vice President of Academic Affairs after all other avenues have been exhausted. Established departmental procedures will be utilized to resolve concerns related to grades received for a class.

Students who believe that the final course grade is incorrect have two weeks (ten working days) after the grade is issued to appeal the grade. Students who believe that a grade earned in a class activity is incorrect have one week (five working days) after the grade is issued to appeal the grade. Exceptions require the approval of the Provost/Vice President of Academic Affairs.

## **15. Repeated Course Fees**

Repeated Course Fee (Non-Refundable) (Effective Fall 2007): SB1, General Appropriations Act, 79<sup>th</sup> Legislature, Regular Session, III-251, §49, limits formula funding for a course for which a student would generate formula funding for a third time. Students attempting a course for the third time will be charged an additional fee of \$60.00 per semester credit hour.

## **16. Campus Safety and Emergency Response**

## **18. Gang-Free Campus Statement**

Premises owned, rented or leased by Laredo College, and areas within 1,000 feet of the premises are “gang-free” zones. Certain criminal offenses, including those involving gang-related crimes, will be enhanced to the next highest category of offense if committed in a gang-free zone by an individual 17 years or older. See Texas Penal Code, Section 71.028, for the consequences of engaging in organized criminal activity within “gang-free” zones.
